## CITY OF OPP 2020 Opp Rattlesnake Rodeo Food Vendor Rules

- SHOW DATES: March 28-29, 2020
- LOCATION OF SHOW: Channell-Lee Football Stadium, 500 Brantley Street, Opp AL, 36467 Behind Mizell Memorial Hospital.
- NO PETS ALLOWED
- ALL TRAFFIC MUST FLOW TO THE RIGHT ONCE INSIDE THE STADIUM.
- No refunds due to cancellations, rain or any other reason.
- The committee has the right to refuse any vendor misrepresented. Menu/vendors will be limited. Menu selection at the discretion of the committee. **MENU PRICES MUST BE VISIBLE.**
- Spaces are 12 x 12. Space fee is \$200. Electric fee is \$100 for (1) 110 or 220 outlet. City License fee is \$10. Space area includes tongues, racks, tie downs, etc. No sharing or subleasing spaces.
- YOU MUST KEEP YOUR AREA CLEAN, PLEASE BAG TRASH AND PLACE AT BACK OR SIDE OF SITE FOR PICK UP DURING THE SHOW AND AFTER THE EVENT IS OVER.
- No alcoholic beverages allowed on site; no obscene items; no fireworks; no firearms.
- City of Opp will not be responsible for loss or theft. Overnight security will be provided.
- After events are over please take down in an orderly manner, please do not drive on playing surface of the football field.
- ALL VENDORS SETUP will be Friday March 27, 2020 from 10am until 9pm. No vehicles will be
  allowed in the stadium until after events are over. FOR RESTOCKING you may drive in early am
  and must be out by 7:30am. Set up time is very congested. Please unload and remove trailers
  and vehicles as quickly as possible. This allows for others to set up as well.
- Exhibitors are responsible for manning their booths; four people will be given free entry with each booth. Additional help will need to purchase vendor pass for \$10 each. Exhibitors will be provided with two (2) parking passes.
- Each vendor is responsible for following all Alabama Health Department rules and regulations as well as fire safety codes. Must have fire extinguishers to code (See Fire Marshal Concession Guidelines). Inspection will be late Friday and early Saturday.
- Each vendor must meet the National Electrical Code Standard.
- Deadline for show applications are Friday March 20, 2020. Keep in mind the spaces fill quickly.
